REORGANIZING THE MUNICIPAL SOLID WASTE MANAGEMENT BOARD OF THE MUNICIPALITY OF SANTA MARIA, BULACAN"

WHEREAS, Section 16 under "State Policies" of 1987 Philippine Constitution enunciates that "The state shall protect and advance the right of the people to a balanced and healthful ecology in accord with rhythm and harmony of nature";

WHEREAS, the Municipality of Santa Maria approved Ordinance no. 182 providing for an Ecological Solid Waste Management Program pursuant to the provisions of RA 9003, known as Ecological Solid Waste Management Act of 2000;

WHEREAS, the new law assigns the primary task of implementing waste management to Local Government Units and with the help of the private sectors, the recycling and manufacturing industries, non-government organization and cooperatives are given opportunities to work with the government counterparts in the setting of guidelines and procedures in solid waste management, formulating and monitoring Solid Waste Management Plans and Programs;

WHEREAS, recent changes in leadership, including the appointments of PNP Chief PLTCOL. Voltaire Rivera, and Liga ng mga Barangay President, Leovigildo A. Ramos, alongside the election of SK Federation President Marco Trajano, and changes in the composition of Sangguning Bayan Committees on Environmental Protection and Natural Resources, Health, Sanitation, and Nutrition, and Social Services, in addition to the appointment of the new Municipal Budget Officer, Lorena F. Gonzales, necessitate an adjustment to Executive Order No. 039-2022 to ensure alignment with the current law enforcement leadership, specifically for the Solid Waste Management Board

NOW THEREFORE, I, BARTOLOME R. RAMOS, Municipal Mayor of Santa Maria, Bulacan, by virtue of power invested in me by law, do hereby order the, "Reorganization of the Municipal Solid Waste Management Board of the Municipality of Santa Maria, Bulacan".

SECTION II. FUNCTIONS, POWER and DUTIES. The Municipal Solid Waste Management Board shall have the following duties and responsibilities:

- 1. Develop the Municipal Solid Waste Management Plan that shall ensure the long-term management of solid waste, as well as integrate the various solid waste management plans and strategies of the barangays in its area of jurisdiction. In the development of Solid Waste Management Plan, it shall conduct consultations with the various sectors of the community;
- 2. Adopt measures to promote and ensures the viability and effective implementation of solid waste management programs in its component barangays;
- 3. Monitor the implementation of the Municipal Solid Waste Management Plan through its various political subdivisions and in cooperation with the private sector, the NGO's, and People's Organization;
- 4. Adopt specific revenue gathering measure to promote the viability of its Solid Waste Management Plan;
- 5. Convene regular meetings for purposes of planning and coordinating the implementation of the solid waste management plans of the respective component barangays (once every quarter);
- 6. Oversee the implementation of the Municipal Solid Waste Management Plan;
- 7. Review every two (2) years or as need arises the Municipal Solid Waste

 Management Plan for purposes of ensuring its sustainability, viability,

effectiveness and relevance in relation to local and international developments in the field of solid waste management;

- 8. Develop the specific mechanics and guidelines for the implementation of the Municipal Solid Waste Management Plan;
- 9. Recommend to appropriate local government authorities' specific measures or proposals for franchise or build-operate transfer agreement with duly recognized institutions, pursuant to R.A 6957, to provide either exclusive or non-exclusive authority for the collection, transfer, storage, processing, recycling of disposal of municipal solid waste. The proposal shall take into consideration appropriate government rules and regulations on contracts, franchises and build-operate-transfer agreements:
- 10. Recommend resolutions and ordinances to the Sangguniang Barangay that will ensure enforcement and implementation of its solid waste management program;
- 11. Recommend measures and safeguards against pollution and for the preservation of the natural ecosystem; and
- 12. Coordinate the efforts of its component barangays in the implementation of the Municipal Solid Waste Management Plan.

SECTION III. SECRETARIAT – The Municipal Environment and Natural Resources Office (MENRO) shall act as the Secretariat of the Municipal Solid Waste Management Board.

SECTION IV. MEETINGS. The Municipal Solid Waste Management Board shall meet regularly once every quarter on a date and place to be determined by the body. The Chairperson shall convene special meetings as may be necessary.

SECTION VI. EFFECTIVITY. This Executive Order takes effect immediately.
