#### **EXECUTIVE ORDER NO. 019 - 2024**

### AN ORDER ORGANIZING THE TASK FORCE KALINISAN IN THE MUNICIPALITY OF SANTA MARIA, BULACAN

WHEREAS, Municipal Ordinance No. 586, also known as "The New Environment Code of Santa Maria, Bulacan," is designed to ensure the comprehensive and effective management and disposal of solid waste by the local government;

WHEREAS, the Municipal Environment and Natural Resources Office is entrusted with the specific responsibility of implementing the aforementioned ordinance:

WHEREAS, recognizing the imperative to establish the "Task Force Kalinisan" to facilitate efficient Solid Waste Management and ensure the ordinance's effective implementation;

WHEREAS, the members of Task Force Kalinisan are comprised of MENRO Staff, employees from LGU Offices, Barangay Officials, and volunteer citizens distinguished by their good moral character and passionate commitment to environmental stewardship, henceforth referred to as "Pulis Kalinisan";

NOW, THEREFORE, I, BARTOLOME R. RAMOS, Municipal Mayor of Santa Maria, Province of Bulacan, by virtue of the authority vested in me by law, hereby order the establishment of the Task Force Kalinisan in the Municipality of Santa Maria, Bulacan



SECTION II. DUTIES AND FUNCTIONS. The Task force shall perform the following duties and functions:

- 1. Monitor and inspect all areas utilized as dumping sites within the municipality, in collaboration with law enforcement and Barangay Officials.
- 2. Conduct inspections of all establishments and institutions within the municipality to ensure compliance with Municipal Ordinance No. 586.
- 3. Issue citation tickets to, or apprehend, individuals found violating any provisions of Municipal Ordinance No. 586. For violations committed by corporations, criminal liability shall be attributed to their responsible officer(s).

4. Propose measures to the Municipal Mayor for the effective implementation of Municipal Ordinance No. 586.

SECTION III. TRAINING. Task Force Kalinisan members shall undergo necessary training to equip them with the qualifications and technical expertise required to fulfill their responsibilities effectively.

SECTION IV. SEPARABILITY. Should any part, section, or provision of this Executive Order be deemed invalid or unconstitutional, the remaining provisions unaffected thereby shall remain in full force and effect.

**SECTION V. EFFECTIVITY.** This Executive Order takes effect immediately.
