#### **EXECUTIVE ORDER NO. 021 - 2024**

### "RE-ORGANIZING THE LOCAL PRICE COORDINATING COUNCIL (LPCC) IN THE MUNICIPALITY OF SANTA MARIA, BULACAN"

WHEREAS, Republic Act No. 7581 otherwise known as Price Act was enacted to ensure the availability of basic necessities and prime commodities at reasonable prices at all times:

**WHEREAS**, the Price Act strictly provides protection to consumers against hoarding, profiteering, and cartels of basic goods especially during calamity, emergency and widespread illegal manipulation;

WHEREAS, to implement the provisions of the said Price Act the Municipal Government is mandated to create and organize the Local Price Coordinating Council.

WHEREAS, pursuant to DTI-DA-DOH-DENR Joint Administrative Order No. 1, s. 1993 the Local Price Coordinating Council shall have the following powers and functions:

- 1. Coordinate and rationalize programs of member-agencies in the respective provinces, cities and municipalities to stabilize prices and supply of basic necessities and prime commodities;
- 2. Recommend to the National Price Coordinating Council or to the implementing agencies suggested retail prices of basic necessities and prime commodities;
- 3. To conduct in-depth analysis on the causes of price fluctuations; and
- 4. To recommend steps to correct unwarranted price increases and supply shortages.

WHEREAS, the recent changes in the composition of the Sangguniang Bayan Committee on Trade, Commerce and Industry emphasize the need for adjustment to Executive Order No. 023-2022 to ensure alignment with the current law enforcement leadership, specially for the Local Price Coordinating Council.

NOW, THEREFORE, I, BARTOLOME R. RAMOS, Municipal Mayor of Santa Maria, Bulacan, by virtue of the power vested in me by pertinent laws, hereby create and establish the Local Price Coordinating Council of the Municipality of Santa Maria, Bulacan as follows:
