EXECUTIVE ORDER NO. 050-2024

AN ORDER APPOINTING MR. MARCO B. TRAJANO, PRESIDENT OF THE PEDERASYON NG SANGGUNIANG KABATAAN, AS EX-OFFICIO MEMBER IN LOCAL SPECIAL BODIES

WHEREAS, Republic Act No. 10742, otherwise known as the Sangguniang Kabataan Reform Act of 2015, mandates the inclusion of youth representatives in local governance structures, granting the duly elected president of the Pederasyon ng Sangguniang Kabataan (SK) an ex officio membership in the Sangguniang Bayan at the municipal level;

WHEREAS, Section 22 of Republic Act No. 10742 also stipulates that SK officials are entitled to become members of local special bodies, thereby ensuring youth representation in the formulation of policies and programs in various sectors such as education, health, peace and order, and local development;

WHEREAS, DILG Memorandum Circular No. 2024-128 strengthens the directives of the Sangguniang Kabataan Reform Act by instructing all local government units to ensure that the SK Federation Presidents are appointed as ex officio members of the Local School Board, Municipal Peace and Order Council, Municipal Development Council, Local Health Board, Municipal Council for the Protection of Children, and Municipal Tourism Council;

NOW, THEREFORE, I, BARTOLOME R. RAMOS, by virtue of the powers vested in me by law, do hereby order the following:

SECTION 1. APPOINTMENT OF EX-OFFICIO MEMBER. The duly elected federation president of the Sangguniang Kabataan, Mr. Marco B. Trajano, in the Municipality of Santa Maria is hereby appointed as an ex officio member of the following local special bodies:

- 1. Local School Board
- 2. Municipal Peace and Order Council
- 3. Municipal Development Council
- 4. Local Health Board
- 5. Municipal Council for the Protection of Children
- 6. Municipal Tourism Council

SECTION 2. FUNCTIONS AND RESPONSIBILITIES. Mr. Marco Trajano, as the SK Federation President and an ex officio member of these local special bodies, shall have full participatory rights in all meetings, discussions, and decision-making processes, ensuring that the voice of the youth is represented in the formulation of programs and policies that directly impact the community.
