AND MS. JENY SY CO FROM AGRICULTURAL TO LIGHT INDUSTRIAL USE

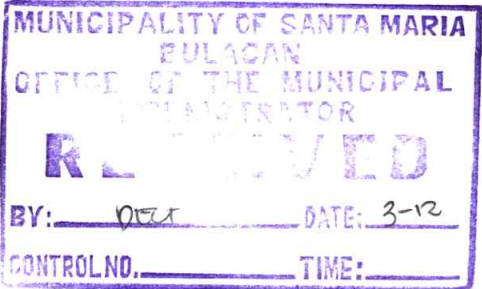

agricultural to light industrial use in favor of Mr. Jacky H. Lin and Ms. Jeny Sy Co.

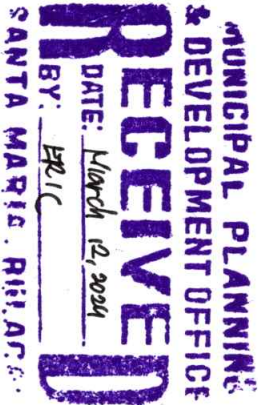

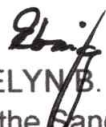
