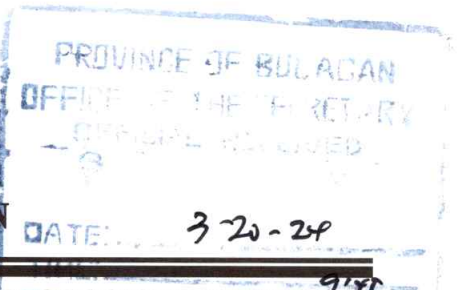

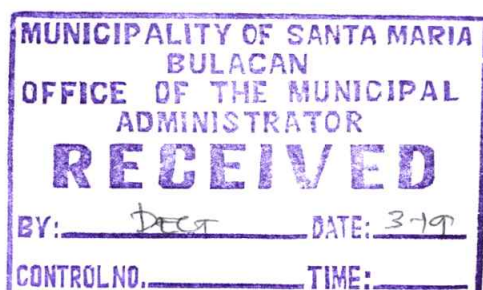
On motion of Hon. Leovigildo A. Ramos duly seconded by all Sangguniang Bayan Members

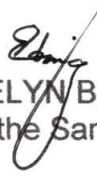

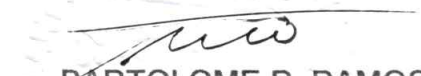
