AN ORDINANCE RECLASSIFYING A PARCEL OF LAND WITH AN AREA OF 5,137.SQ. METERS, MORE OR LESS, LOCATED AT BARANGAY CAMANGYANAN, SANTA MARIA, BULACAN IN FAVOR OF MAGNA PRIME CHEMICAL TECHNOLOGIES, INC. FROM AGRICULTURAL TO LIGHT INDUSTRIAL USE

PREAMBULATORY CLAUSE

WHEREAS, Section 447(a) (2) (viii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the Sangguniang Bayan to reclassify lands within its territorial jurisdiction;

WHEREAS, Section 20 of the same Code provides that the Sangguniang Bayan, through an ordinance, may reclassify lands and provide for the manner of their utilization or disposition where the land shall have substantially greater economic value for residential, commercial, or industrial purposes;

WHEREAS, per Memorandum Circular No. 54, issued in 1993, entitled "Prescribing the Guidelines Governing Section 20 of RA 7160 Authorizing Cities and Municipalities to Reclassify Agricultural Lands into Non-Agricultural Uses," the Municipality of Santa Maria, being a First-Class municipality, is authorized to reclassify ten percent (10%) of its agricultural land;

WHEREAS, Ms. Mary Jane A. Manuel, Admin. Specialist and Authorized Representative of Magna Prime Chemical Technologies, Inc., applied and submitted all requirements for the reclassification of a parcel of land located at Barangay Camangyanan, Santa Maria, Bulacan from agricultural to light industrial use on 26 January 2024 and was referred to the Committee on Land Use and Agrarian Reform on 05 February 2024;

WHEREAS, the applicant's intention for reclassification is to construct and put-up a warehouse;

NOW, THEREFORE, on motion of Hon. Leovigildo A. Ramos duly seconded by SB Members Nelson Carmelo V. Luciano, Jesus B. de Guzman, Jr., Marisa T. Tuazon, Marco B. Trajano, Mark Angelo R. Clemente and Carl Gerard Castillo

BE IT ENACTED by the Sangguniang Bayan of Santa Maria, Bulacan in session duly assembled that:

SECTION 1. A parcel of land with an area of 5,137 square meters, more or less, located at Barangay Camangyanan, Santa Maria, Bulacan is hereby reclassified from agricultural to light industrial use in favor of Magna Prime Chemical Technologies, Inc.
