### **ORDINANCE NO. 678**

AN ORDINANCE RECLASSIFYING PARCELS OF LAND WITH A TOTAL AREA OF 12,122 SQ. METERS, MORE OR LESS, LOCATED AT BARANGAY TUMANA, SANTA MARIA, BULACAN IN FAVOR OF SPOUSES JAMES LAI AND AILEEN LAI FROM AGRICULTURAL TO LIGHT INDUSTRIAL USE

#### PREAMBULATORY CLAUSE

WHEREAS, Section 447(a) (2) (viii) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, authorizes the Sangguniang Bayan to reclassify lands within its territorial jurisdiction;

WHEREAS, Section 20 of the same Code provides that the Sangguniang Bayan, through an ordinance, may reclassify lands and provide for the manner of their utilization or disposition where the land shall have substantially greater economic value for residential, commercial, or industrial purposes;

WHEREAS, per Memorandum Circular No. 54, issued in 1993, entitled "Prescribing the Guidelines Governing Section 20 of RA 7160 Authorizing Cities and Municipalities to Reclassify Agricultural Lands into Non-Agricultural Uses," the Municipality of Santa Maria, being a First-Class municipality, is authorized to reclassify ten percent (10%) of its agricultural land;

WHEREAS, Mr. Ezekiel Corpuz Acbang, Authorized Representative of Mr. James Lee Lai, applied and submitted all requirements for the reclassification of a parcel of land located at Barangay Tumana, Santa Maria, Bulacan from agricultural to light industrial use on 26 March 2024 and was referred to the Committee on Land Use and Agrarian Reform on 01 April 2024;

WHEREAS, a public hearing was convened on April 24, 2024, and was attended by the Chairman of the Committee on Land Use and Agrarian Reform, Punong Barangay of Barangay Tumana, and representatives from various municipal departments, including the Municipal Zoning Officer and Municipal Planning and Development Coordinator. In addition, Mr. Ezekiel Corpuz Acbang and Mr. Paul John C. Balana were present along with nearby residents;
